- **R-5** The updated upgrade request form was distributed.
- **R-6** Presented NYSW's zero tolerance policy
- **A-7** NYSW has affiliated clubs listed on their website. This is being used to decide where to hold grade 9 referee courses to provide referees where needed. DRA's should make note of the clubs in their respective area and find out if they have house leagues.
