  - o Rochester Not notified of new treasurer

  - Southern Tier check for mentoring was supposed to be written to Southern Tier Youth Soccer League. Check was written to an individual with no W9 on file. Must have W9 or funds returned by November 30, 2018. Funds have been released to league and paid to mentors

## III. SRA Report

- Tata will mail out Emeritus badges individually
- USASA Annual Meeting, Buffalo, NY 9/21-9/23
  - Highest attended ever
  - o Referee Grade Changes (proposed)

- 9-8-7 will be combined into one grade
- 6 remains State Referee
- 5 Regional Referee
- 4-3-2-1 National/International Referees
- No word on impact to Assessment/Instruction process
- Assessment Referees will pay for assessments at registration. Assessors will be paid following submission of report to SDA and referee
  - Wu will work out payment details
- Assigning of assessors
  - Referees will no longer choose games to be assessed. They will be assigned by district/regional coordinators as follows:

- WNYSRA AGM November 2019, location TBA
  - Ross Motion AGM to be held at Radisson First weekend in Nov 2019
    - Second Campbell
  - o Ross Amended Radisson used if available
    - Second Campbell
    - Discussion
      - Ross Historically, no bids have been made by other districts
      - Campbell Rochester is central to largest number of referees
    - Call the Question (cloture) -- Jaspe
      - Vote Yes (Unanimous)

- Annual awards will be presented
- Potential to bring in USA WWC crew to speak
- Looking for ways to attract younger referees
  - Presentation by Kris Bailey, SDI Alabama targeting less experienced referees
- o SRC meeting (SRC members attendance mandatory)
- Use for Assessor/Instructor Recert
- Registration is confirmed by referee's name on the spreadsheet (approved by SRA)
- Recommendation: Units should waive local dues for first year referees

## IV. SYRA Report (Campbell)

- State Cup No real issues or complaints
- Eastern Regional Presidents No referees supplied due to no NY West teams sent
- Eastern Regional ODP Girls (Lawrenceville/Princeton NJ) 10 referees, 2
  assessors. 4 referees invited to Eastern Regional Finals Adam Brzozowiec,
  Hunter Brzozowiec, Danny Iadanza, and Alex Parent. Only Hunter Brzozowiec
  was able to attend
- Eastern Regional League Finals (Kirkwood, DE) − 3 invited to regionals (David Rousseau, Danny Iadanza, Antonio Triana). Mr. Iadanza and Mr. Triana were invited to represent the Premier League at the Regional Championships
- Eastern Regional Championships 17 referees, 2 assessors sent, Antonio Triana invited to Nationals, Alex Parent as backup. Antonio was unable to attend due to family emergency
- Young Referee of Year:
  - Adam Brzozowiec (also Region 1 young referee of the year and excellent chance to win national award)
  - Alisa Hines
- Regionals

- States are no longer required to send referees to regional tournament
- Game fees will be offered in place of stipend. Travel allowance will be removed
- o Region 1 committee will nominate referees instead of states
  - SYRAs objected, Region went forward anyway
  - Region will send list of potential candidates and SYRA will approve each candidate or not
  - List received is inaccurate referees not registered, moved, not from WNY, etc...
- Letter from Frank Giancroce resigning as Eastern Regional Referee Administrator
- Number of teams expanded, tournament expanded to 7 days with day off in the middle
- Head of Delegation position eliminated
  - Objection filed with NYWest
- Assume that NYWest will no longer support referees going to Regionals
- Region will hire a replacement for Frank
- Regional Tournament/National Champ no longer considered referee identification events. There will be a DA event same week as Regionals in 2019
  - US Soccer will no longer provide referee coaches
- Jaspe Region can coordinate assessment and instruction programs if they wish to fund
- Serrano Can we shift resources away from Regional to DA for referee development? Other tournaments?
  - Campbell will require policy changes to financially support DA referees. No changes for 2019

## V. SDI Report (Ross)

- Grade 8s who want to go to advanced recert should get override code from DRA
   Only referees who can handle subject matter
- Batavia Issue No recerts scheduled for Batavia invite Buffalo and Rochester to schedule something closer to Genesee County
- Remind GameOfficials users to subscribe for reminder/group email messages must have at least one email address and one phone number displayed publicly.
- Tata Encourage minimum age of 14 for entry classes
- Entry level classes
  - o Classes will be set up in GO in near future
  - Marketing assistance available some areas getting very low turnout
  - o If fewer than 15 participants, district must pay a portion or cancel the class
  - o If greater than 40, split into multiple classes
  - Outlook for next year 8 hours online, 8 hours field for 2020
    - Need to find facilities where field sessions can occur
    - Materials under development
    - Tata Northern climate SRAs are objecting to field training requirements
  - We cannot set additional standards for referee registrations (US Soccer policy)
    - RDYSL require referees to attend Referee 101 and field clinic –
       This cannot be enforced
    - Additional clinics can be offered, but not required

## VI. SDA Report (Jaspe)

- Biggest change is addition of assessment fees to referee registration. Email sent to all applicable referees explaining process
  - Assignors will now select match(es) to be assessed. If those matches are not of sufficient quality, WNYSRA will pay for re-assessment

- New bylaws for Buffalo & WNY RU still need review by SRA

  - o Batavia referees will be able to self-select a new district
  - Ross Eliminate from website & GO ASAP to avoid referee confusion.
     Will contact Greg Irwin for changes to wnyreferee.org
- Wu Local account issues
  - Rochester Has no checks gets bank drafts to cash or uses ATM machine and supports with receipts

- o Tata recommend dissolving local accounts
  - Pitcher objection to removing local accounts process for paying for small expenditures (pizza, room rent, etc...) too difficult to send through State Treasurer
