## IV. SRA Report (Tata)

- OMS requires special procedure for transferring data/money to national office. Requires elevated credentials, which Tata has been unable to acquire. No response from national office
- Almost 200 referees have been state-approved but no referees have been registered with US Soccer
- None will be sent to national for the next two weeks as Tata will be out of town
- Learning Center: Generally working most problems are referees not following directions with credentials
  - o R-<16-digit USSF ID>/Last Name (All Caps)
- Entry-level courses
  - We are way behind -25 people registered for online, 12 have completed. 12 registered (all Buffalo) for in-person clinic
  - o Ross: process will be evaluated and will likely change
  - 2019 525 new referees Rochester will take a big hit if numbers are low (~1/3 of referees were new last year)
  - Extend entry courses into May if instructors are available Risk Management may be an issue
- Shortage of Regional Assessors to cover existing regional referees. Numbers may drop in 2020 due to new fitness requirements

- Grassroots Coaches different tiers of coaches
- Meeting dates for 2020 sent out Note April meeting will be March 29 due to Easter

## V. SYRA Report (Campbell)

- Bill will be attending Young Referee of the Year banquet in Baltimore
- Bill will be reaching out to invitees for regional tournaments very soon (February)
- Names for State Cup should be submitted by 1 April Tournament is 29-31 May 2020

## VI. SDI Report (Ross)

- Registration: Do not send Tom emails asking for referees' statuses
- Badges are not the responsibility of instructors. District Representatives should be distributing badges
- Re-certs Try not to enroll more than 60 for a recert clinic; not as effective
- Entry clinics 10-30 people
- We will do an entry-level instructor course in 2020 on Jan 31 & Feb 1 Planned 2021 for instructor and assessor to combine into referee coach

## VII. SDA Report (Jaspe)

- We will continue to run assessment program as we have until we get solid information about new program/classifications to assess adult matches. We will continue to use GameOfficials
- Lauren Dearman has taken coach course and is working on post-course requirements

## IX. Binghamton

- Proposal for 3-District mentoring (\$2,400) attached (Binghamton/Elmira/Ithaca)
  - Ross: Need to study/report (statewide) what effect mentoring is having toward retention (not as condition for approval of proposal at this time)
  - o Pasnak: Need SRC guidelines to define mentoring programs.
  - o Pasnak: Consider assigning assessors to State Cup Playdowns

- o Campbell: Bin-Elm-Ith mentor plan is for year 3-8 referees
- Tata: Request to remove State Cup Playdown from mentoring request. Guidelines on mentor qualification are listed in last year's proposal. Standard grant is \$2,000 per district – this proposal covers 3 districts
- Motion to accept proposal:

## X. Buffalo (report given by Tata)

- 4 recerts remaining 255 referees registered, 260 unknown
- Buffalo requests mentor program funds for 2020 (written request submitted by Cathy Jaspe)
  - Ross What criteria are used to assess success/failure & drive improvement of the program?
    - Serrano Measurements on referee performance compared across the season/multiple mentors to evaluate individual referee improvement
    - Tata data would be useful to filter to SDI for inclusion in recert/entry level courses
  - U10A 3 referees mentor is referee, ARs are mentees Tata: How effective is mentoring while refereeing?
    - Serrano Mentors are all effective/experienced enough to be able to mentor while refereeing. Scheduling issues limit number of mentors available
  - U10B single referee, mentor off-field
  - Ross Have you utilized retired referees?
    - Ross/Pasnak Needs risk management/Safesport
  - Pitcher moves to award
    - Second Campbell
    - Approved Unanimously
