IV. SRA Report (Tata)

- Referee Registration Status
 - o Better for 2022, but not nearly to previous levels. 200 pending to process from final recertification sessions
 - Many referees have not attended a recert We are investigating holding an additional session for an additional \$35 fee. This fee will rise by \$10 for every year – Possibly an in-person advanced recert in the location where the most referees will be served. DRAs please determine numbers for each district
 - Last day for registration is April 30, 2022
 - Risk Management starting to see delays due to large numbers of clubs being processed. Referees should strive to take care of this earlier in the year
 - Additional Entry Level courses are still possible, even after 30 April, based on requests from districts and instructor availability
 - o Instructor, Assessor registration complete
- Policies and Procedures Finalization (see attached P&P document)

- Adds Game Reports Enforcement and wording changes around assessments/evaluations

V. NYSWYSA (Brame)

- Grant received to do referee recruitment at WNY Colleges and Universities
 - O Tata Target those who have been cut from varsity teams
 - Randall Target those who play club/recreational/intramurals
- Abuse must be stringently reported NYSWYSA get reports every week from teams of referee abuse but no accompanying referee reports – want to deal with this.
- Request that if we still have interested parties, that we continue to hold entry level classes
 - Info from Tom Ross: We recruit large numbers of young referees who tend not to have time and referee very few games
 - o 50% or fewer return for second year
- Any ideas for recruiting older referees will be considered for potential grant requests to US Youth Soccer and US Soccer.
 - o Ross Advertising during National Team matches
 - o Byrnes Recruit at State Cup
- Alex would like to attend regularly as NYSWYSA Designee

VI. SYRA Report (Campbell)

- State Cup New contract favorable to referees
 - o June 3, 4, 5
 - o To nominate referees, contact Campbell by 18 April

- Young Referee of the Year invites sent before June 1 in order to have all paperwork complete before students prepare for college – will send out email request to districts
- Regional Invites: Nominees reviewed by Campbell and Tata
- State Cup playdowns have gone to self-scheduling those games will outrank others on priority list

VII. SDI Report (Ross)

- Recert clinics/training -- We need to know from districts who still desires to attend a recert clinic so we can schedule any additional late recert sessions
- Fall entry level classes are possible, but will use previous year's materials and referees will need refresher (attend recert) on new year's changes
- Mentor classes will be needed (2023 will be final year for Instructor/assessor registrations). Would be best to structure around tournaments. Requirements:
 - Classroom
 - Video Review
 - Field Exercise
- We will not run referee coach training because of likely low demand and high cost
- Potential shift to Learning Center because OMS is not meeting our needs
 - Drawback: National background check is required, which is additional expense, and NYSW does not accept. – Brame – National does not include 7-year county check – Will verify whether that has changed
 - o Pro: Will consolidate registration to a single web portal
