#### **ARBITER: DISCUSSION**

SRC & WNY are trying to find a way so all of WNY can share possible cost savings of this program. Handed out the Arbiter Vision Statement that details how the Arbiter System will be operated, the method of payment of the system and the structure for operation of the system.

Each current license number will remain with the district that currently owns it. We are simply trying to aggregate all of the districts in WNYSRA for a cost savings.

In the Elmira district, the Arbiter system may be used by both the High School association and the WNYSRA district. Tom Barker recommended that each be set up locally as separate sports. Should this become an issue in the future, WNYSRA will set up a different account for the Elmira group.

President of the Rochester Unit, Dave Weaver, sent an email on 1/13/07 with his thoughts to the SRC. Each assignor will purchase an Arbiter License. Rochester DRA, Bill Bianchi, stated that we must rescind the email that Weaver sent out.

WNYSRA will embrace that 9 districts under each district license number. Each district will report the number of referees, assignors, and assessors to the SRC to gain the cost advantage for 1000 slots with technical support at \$3.00 a person.

#### US CLUB SOCCER: DISCUSSION & IMPACT ON WNYSRA

In Buffalo, one team wants to join the national association of US Club Soccer. Some concern exists with this decision because if there is an assult or abuse onto a referee it has to be dealt with at the US Club Soccer National level.

SRC needs in writing a guideline from the Great Lakes Alliance that their "Friendlies" are under jurisdiction of USSF, and not to be confused with the ASL.

# WNY CLUB QUESTIONAIRE SENT FROM SRA TO ALL MEMBER CLUBS/LEAGUES OF NYSWYSA.

The point of the questionnaire was to attempt to find out exactly where the WNYSRA stands in terms of covering all youth matches in the state with certified officials using the diagonal system of control and USSF certified assignors.

One thing that has already come from this are the two new proposals presented by the SRA/SYRA in conjunction with the SDI at the meeting. The first is to resurrect the Grade 12 (Assistant Referee) badge. The second is a new cost structure to be offered to youth soccer clubs for both the Grade 12 and Grade 9 (Recreational Youth Referee) classes stipulating that the club must do the advertising and setup of the classes in order to receive the discount.

1-AD SYRA will attempt to come up with a "club friendly" version of these documents will be written and posted to the WNYSRA web site and published in an upcoming issue of Striker West (NYSW).
